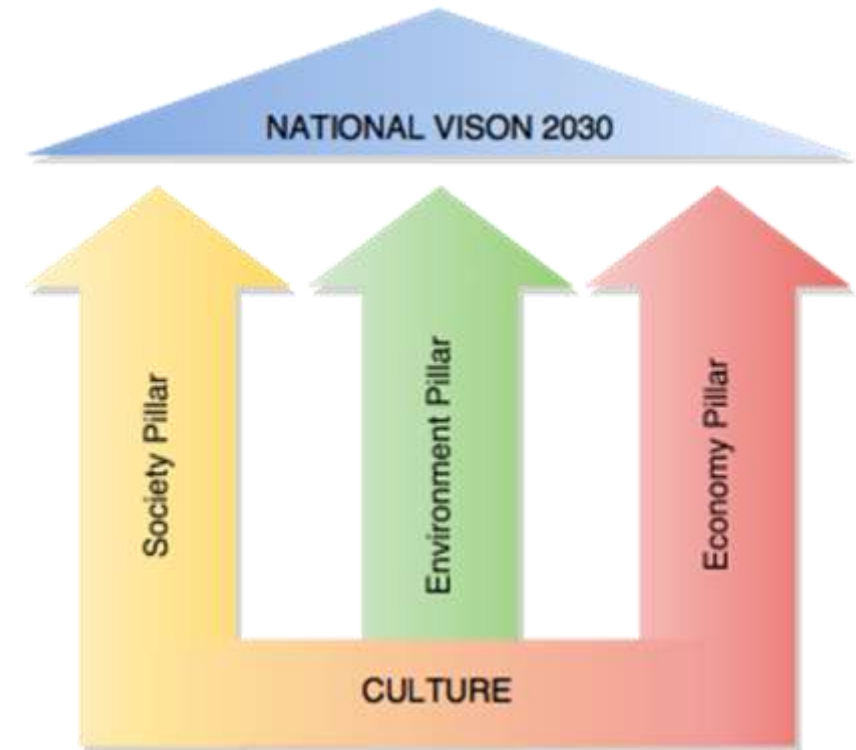
# National Sustainable Development Plan

- Guides and informs new government policy

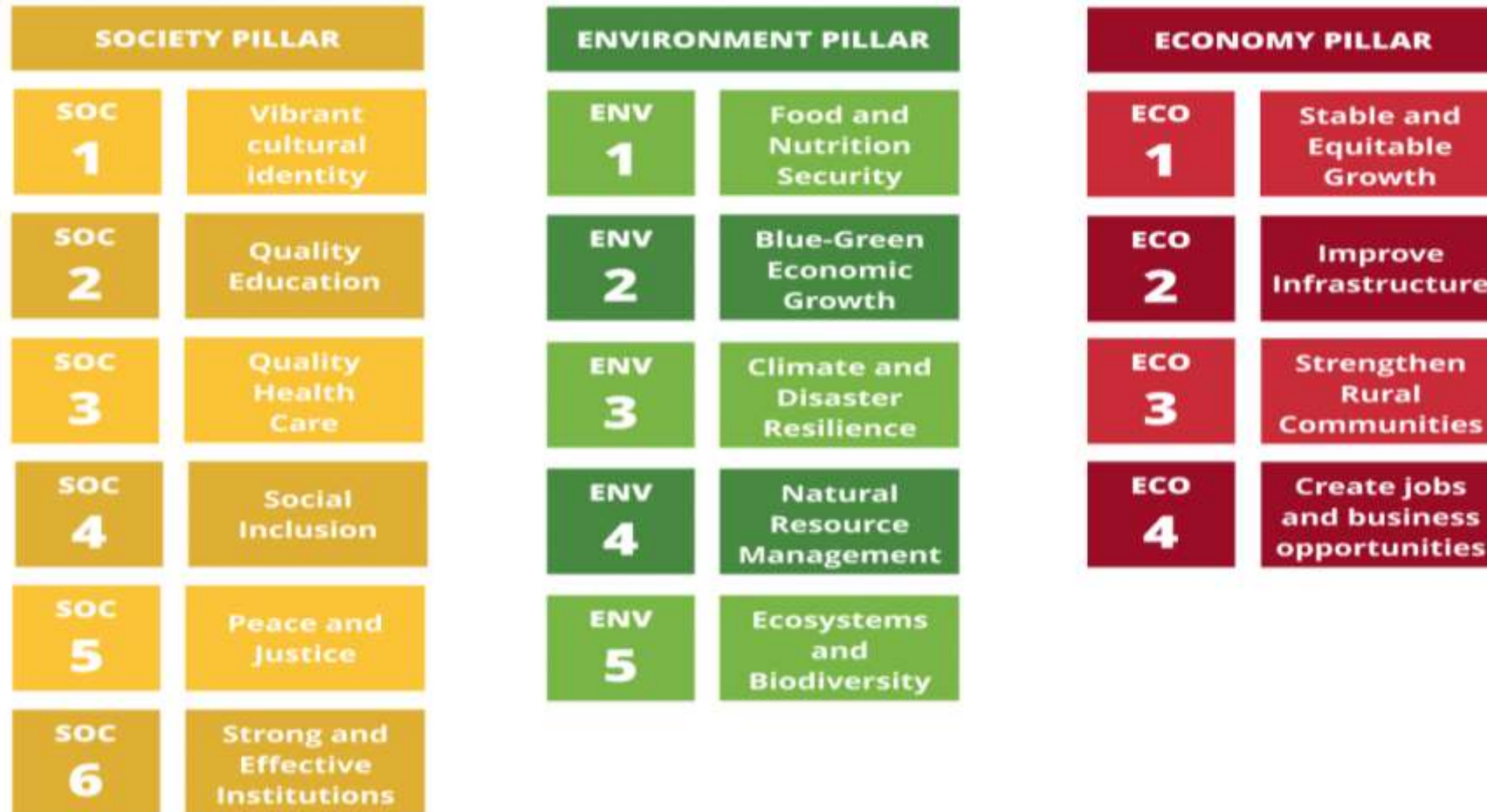

### **POLICY OBJECTIVES**

- ENV 3.1** Institutionalise climate change and disaster risk governance and build institutional capacity and awareness
- ENV 3.2** Improve monitoring and early warning systems
- ENV 3.3** Strengthen post-disaster systems in planning, preparedness, response and recovery
- ENV 3.4** Promote and ensure strengthened resilience and adaptive capacity to climate related, natural and man-made hazards
- ENV 3.5** Access available financing for climate change adaptation and disaster risk management



# Budget Priorities 2018

## **Priority Outcome 6:** Improved resilience and natural resource management

- Improved climate change adaptation and disaster risk management governance and practices, particularly ability to leverage access to further donor financing in these sectors
- Increased equitable, accessible and affordable water supply and sanitation
- Stronger institutions and governance that protect our environment and natural resources
